Although UV stabilizers have been added to our products, slight discoloration can occur with extended periods of sunlight; using covers can limit discoloration. This warranty is issued to the original purchaser only, and is not transferable in any way at any time. The manufacturer will replace any defective parts with similar or like parts of the same. Accessories are subject to the 1-Year Limited Product Warranty below.
